- If the Developer provides the curb stop, meter, meter box, meter vault if needed, appurtenances, and labor to install, the City would only charge the Capacity Fee to the Developer and the Administrative Fee for setting up the customer account would be paid by the customer.
- If the City provides the curb stop, meter, meter box, meter vault if needed, and contractor labor to install, then the sum of all these costs plus the Capacity Fee and the Administrative Fee for setting up the customer account would be paid by the customer.
